For purchases via our website, by clicking on the blue "Register My Interest" button you agree to the terms of this agreement which will bind you. If you do not agree to these terms and conditions you must cease to continue to purchase any Services from us.

## 1. Definitions

"Fees" means the fees paid by you to Solution Focused Possibilities for the Services.

"Services" means the provision of the Online Course and/or the Taught Course and/or the Course Materials together with such other services as agreed from time to time and purchased by you through the Website or by email.

"you" means the individual purchasing the Services.

## 2. Cancellation

2.1. Once you have purchased the 'Simply SFP' course, and we have formed a legally binding agreement with you (in accordance with clause 3.4 in the 'Standard Terms for the Purchase of Online and Taught Courses' document), then you may only cancel your purchase before, or on, the date of 11<sup>th</sup> April 2022, exactly two weeks before the 'Simply SFP' services commence.
